Partnerships for Success (PFS)

Initiatives:

- <u>Transfiguration Greek Orthodox Church</u>- To build capacity within the faith-based community, an outreach opportunity took place on November 28th with Father Tom of the Transfiguration Greek Orthodox Church in Lowell. We brought a variety of resources and educational materials for Father Tom's congregation. Father Tom noted that there are youth groups within the church that PFS could possibly work with after the holidays.
- <u>UTEC</u>- Following our initial assessment, PFS is identifying and meeting with youth serving organizations in the community. On November 30th, outreach was conducted with one of the program coordinators from UTEC around future collaboration. PFS provided UTEC with educational materials and resources. PFS looks forward to collaborating with UTEC in the future.
- <u>PFS Strategic Plan</u>- PFS Strategic Plan was submitted on December 4th to the grant manager at BSAS for approval.
- <u>Girls Inc.</u> Similar to UTEC, Girls Inc. is a youth serving organization that PFS did not reach out to during our initial assessment. On December 12th, outreach was completed with a program director and a program coordinator where PFS provided resources and educational materials. PFS and UTEC discussed ways they can collaborate moving forward.
- South Bay Community Services- On December 12th, outreach was conducted at South Bay Community Services. PFS met with one of the program director to discuss future collaboration, as well as provided the director with resources and educational materials for youth.
- MIAA Opioid Abuse Prevention Conference- On December 13, PFS took 15 students (12 males, 3 females) to the 2nd Annual Faces of Addiction Conference in Westborough, MA. Students were able to attend workshops and listen to speakers on the dangers of opioid misuse. There will be a follow-up meeting with the students to evaluate their experience and discuss how they will be able to take the information they received and disseminate it to their peers.
