

Project Background

- Greater Lowell Vision Zero Action Plan (2024)
 - prioritize future safety efforts in pursuit of Vision Zero – no roadway-related deaths or serious injuries by 2050
 - Lowell has the region’s most dangerous roadways and intersections
- Lowell Forward Mobility Goals
- City of Lowell received “Safe Streets For All” (SS4A) grant to implement safety measures in a targeted way within three neighborhoods



High Injury Intersections

- Top 10 Intersections
- Top 25 Intersections
- Top 50 Intersections
- Top 100 Intersections


High Injury Network by Town

- Top 1% of Roadway Miles Per Town
- Top 3% of Roadway Miles Per Town


Safe Streets for All Draft Concepts

One-way Street Plan for Back Central




- What we heard: Lots of sidewalk parking and inaccessible sidewalks across the neighborhood
- Proposed plan for converting some streets to one-way to reduce parking on sidewalks

Slower and Safer Streets

- What we heard: Primary concerns with pedestrian safety/infrastructure, poor sightlines, speeding across all neighborhoods
- Two approaches to address these safety issues
 1. **Pedestrian safety projects** at intersection level throughout network
 2. **Projects that reduce speeding** along priority streets

Pedestrian Safety Toolkit

Curb Extensions



Daylighting



Rectangular Rapid Flashing Beacons



Benefit: increases visibility of pedestrians and drivers

Accessible Crosswalks



Raised Intersections + Crosswalks



Pedestrian Crossing Islands



Benefit: provides a safer and more comfortable crossing experience, and reduces speeding

Intersection Realignment




Travel Lane Narrowing



Benefit: tightens roadway to reduce drivers' speed








Speed Reduction Concept Plans

 - Central Street


Reduce speeding on priority streets - Fletcher Street




Reduce speeding at priority streets - Fletcher Street – long term
