



Good Morning,

On behalf of Lowell’s Continuum of Care Advisory Board (CCAB) and the City’s Department of Planning and Development as Collaborative Applicant for the CoC, I am writing to inform you of the following priority placements for the 2017 Continuum of Care Program competitive application. As you know, these scores were derived from a combination of the rating and ranking of each agency’s HUD Annual Performance Report and Local CoC Competition Applications (see attached). The CCAB would like to meet with any interested applicant to debrief them on their final placement score. If your agency is interested in meeting with the CCAB for a debriefing on these scores, the following dates are available: Friday September 8th or 15th between the hours of 8:00 and 10:00 AM. Please let me know the date and time that works for your agency.

Priority Listings were established per the following NOFA regulations,

D. Available Funds. Approximately \$2 billion is available in this FY 2017 CoC Program Competition NOFA.

1. HUD may add to this amount any available funds that have been carried over or recaptured from previous fiscal years.
2. All of the requirements in the FY 2017 application process including requirements for the entire CoC Consolidated Application and the total amount of funding available are contained in this NOFA.
3. **The available amount of funding may not be sufficient to fund anticipated eligible renewal projects in FY 2017.**
4. HUD will continue to require Collaborative Applicants to rank all projects, except CoC planning and Unified Funding Agency (UFA) Costs, in two tiers.
 - a. **Tier 1** is equal to the greater of the combined amount of Annual Renewal Amount (ARA) for all permanent housing and HMIS projects eligible for renewal up to \$1,000,000 or 94 percent of the CoC’s FY 2017 Annual Renewal Demand (ARD), as described in Section III.A.3.a. of this NOFA.
 - b. **Tier 2** is the difference between Tier 1 and the CoC’s ARD plus any amount available for the permanent housing bonus as described in Section III.A.3.j. of this NOFA.
