## THE CITY OF LOWELL'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

The City of Lowell is pleased to announce that **Constellation NewEnergy, Inc.** ("Constellation") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Constellation will provide electric power supply for all consumers participating in Lowell's Program. This Program supports local renewable energy as 59% of the power supply is offset with MA Class I Renewable Energy Certificates (RECs), which is 45% above the current state mandate of 14% for these renewables. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** You will see Constellation printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

\*Rate may increase as a result of a change in law that results in a direct, material increase in costs during the term of the contract.

\*\*GreenUp options are available for \$0.024-\$0.038 per kWh in addition to National Grid's Basic Service rate.

**PARTICIPATING CONSUMERS** will start benefiting from the aggregation rate beginning on the day of the month in October 2019 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**WATCH YOUR NATIONAL GRID BILL FOR FURTHER NOTIFICATION** of the Program.

- Your October 2019 bill will state that you are being switched to **Constellation (Lowell Aggregation)**.
- Your November 2019 bill will show Lowell's new supplier and aggregation rate under "Supply Services".

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will automatically be enrolled. If you do not wish to participate, please follow the instructions specified.

**IF YOU DO NOT WISH TO PARTICIPATE** you must OPT-OUT at [www.colonialpowergroup.com/lowell/](http://www.colonialpowergroup.com/lowell/), click the OPT-OUT button and follow the instructions specified OR call Constellation at (844) 979-0172.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against National Grid Basic Service. However, such savings and future savings cannot be guaranteed.
